8. Approval of Minutes – December 2018

 - *Mick-Provides protection and more companies will donate to a 501(c)3 vs a 501(c)19.
 - *The Legacy Run is a subsidiary corporation of the ALRDOC.
 - *Motion to start the process for creating a 501©3 for the California Legacy Run by Rey Ruiz. 2nd by Mike Smith. Passed by vote of DEC.
- b. Use account to receive donations from Fundly
 - *It was stated that Fundly doesn't take a percentage like GoFundMe does.
 - *Motion for the bank account to receive donations from Fundly by Rey Ruiz. 2nd by Paul LaPierre. Much discussion was held. Motion to table the current motion by Gene Hobdy. 2nd by Pete DePalma. Passed by vote of DEC.
- c. Convention 2019 location
 - *Chapter 108 will not be able to hold the 2019 convention.
 - *Bob Perryman looked into the McClellan center. It wasn't available. Hotels were also too expensive because of short notice.
 - *Warren Halstead gave 2 places that might work. Chapter 31-The post is being remodeled due to asbestos issues. Ch 69- Veterans bldg. is available May 3-5.
 - *Poncho-Talked to JD Bennet about the Clovis Veterans Center. The Clovis Veterans Center wasn't available. Checked on using the conference center at the DoubleTree Hotel in Fresno. It wasn't available.
 - *Mick wanted to give a big thank you to Bob Perryman and Albert Villa who had stepped up to try to help in the last 36 hours. It let Mick concentrate in other areas.

- *Ken-\$2,000 check hasn't been deposited. Will be returned. Mick asked him to write void on the check. He will email Leonard. He will call all who registered at his hotel.
