## 9. Financial Report – Leonard Phillips

- \*Expenses \$51,747.09 including \$23,706 for the Legacy Scholarship Fund.
- \*Deposits \$41,006.74 including patches and Legacy Run donations.
- \*No patch orders in the queue. Sent an email to all outstanding chapters. Some didn't respond.
- \*Need to know what line item to take the new website funds from.
- \*It was decided to take the funds from management reserve. Motion to take \$216 from management reserve for the year's payment for the new website by Mike Killion. 2<sup>nd</sup> by Mike Smith. Passed by vote of DEC.
- \*Motion to accept the finance report as read pending audit by Leonard Phillips. 2<sup>nd</sup> by Debbie Proffitt. Passed by vote of DEC.
- \*Rey-Chapter 328 turned in \$3,156 for VA&R from the Sportster raffle. The check hasn't been cashed yet. Leonard stated that that check never came in. Rey will have the chapter 328 treasurer stop payment and issue a new check.

- \*I am pleased to report that a check in the amount of \$23,706 is in route to the National convention for the American Legion Legacy Scholarship Fund. These are the proceeds from the Inaugural California Scholarship Run. We are in the planning stages for the 2020 state run from Oceanside to Visalia.
