9. Financial Report – Leonard Phillips-ex; asst.-Anthony Serio

*Asked to lead the Santa Inez Valley Day parade. Chapters 66, 371, 534 and 21 participated with 14 riders.

*Went to installations at chapters 66 and 613.

*Went to ch 211 installation on 6/17/17.

*Working with Ways and Means John Carradine to have a booth at next years' Mid State Fair.

*Santa Barbara Riders Foundation contacted them about participating in the July 4th Parade.

They are interested in forming a chapter in Santa Barbara. Will invite them to go to the Lompoc bike night on 6/30 and possibly a meeting in Oxnard.

- a. Quartermaster- Patrick Tafoya
 - *All is going well.

- *Red Friday shirts will be available in the website soon. Shirts are \$15 each. Trying to figure out shipping with the Post Office. Looks like 1 shirt shipping will be \$3-\$4 dollars. 2 or more will be Priority mail. Have shirts up to 3x.
- *Rally patches- state has plenty available. Will just need to order small year rocker.
- *There is 1 order waiting to be filled from the store. The vender we use will be down 3 weeks so there might be a slight delay on orders.

b. Convention and Rally – Dee Pittinger

*RALLY-Emailed the final details. Friday—dinner 5-8pm; sign in; DEC meeting;; Saturday—Registration 7-11am; breakfast 7-11 am; dinner is cook your own; band; Sunday- full rider breakfast available. SOS will be the shuttle all weekend.

*CONVENTION-had a meeting last night. Junior Saio is on contract with help from Dana Higgins. Looking into ways to get grants, etc. % hotels available. The list will be released in January. Holiday Inn will be the host hotel. 30 rooms are blocked. @ RV parks will be available. Plenty of time. There are 9 months left.

*Vests will not be allowed to be worn in any establishment that serves alcohol. They don't allow and type of rider vests from anywhere. Rider shirts are ok.

- *All members need to get the information being disseminated. Need to get information out to membership as a whole.
- *New ID card. Chapters don't need to vote on it. It was voted on by DEC. It wasn't accept it well. Communication was not good to explain. Mick will be there to let anyone know that there were no by laws violated.

e. Safety Committee – Ken White

- * All Area VPs have gotten emails about the California Legacy Run on August 15th. No response from the chapter about anything Friday night. Will be leaving at 7am to get to Fallon, Nevada early evening for Operation Comfort Warrior presentation. It will be a 6 hour ride with no stops. Breaking it up into 110-115 mile legs. Can make the legs longer if ok with riders. The next morning riding from Fallon to Reno. Riders need to register on the National Legacy website and register and pay fees. If staying for the Convention and want access you will have to pay fees to get in the door even if only looking at the vendors.
- *Will be working on each Area and chapter having a Chapter Safety Rep.
- *It's hot. Hydrate and be well fed.

- *Have gotten emails from people wanting to be added as POC and there is no button. Informed that each chapter only gets 3. No complaints from anyone.
- *Debbie mentioned that there is a need for the areas on the COO auto fill not automatically filled in to be filled in, signed then sent. It was asked if those area still needing to be filled in could be highlighted. Jim will look into it.

g. Membership Officer – Gary Teicher

- *Membership report was emailed out.
- -Area 1- 11 chapters 280 riders
- -Area 2- 09 chapters 254 riders
- -Area 3- 17 chapters 421 riders
- -Area 4- 01 chapter 9 riders

- -Area 5- 31 chapters 789 riders
- -Area 6- 14 chapters 301 riders
- *Last year there were 1841 riders, this year 2054 riders.
- *This month chapter 684 added 12 members.
- *Randy-Online rosters are not being updated. Have sent an email to all Area VPs and ch POCs to check rosters monthly and update as necessary.
- *Randy-did a random check of 20 rosters across the Areas. Only 2 had been updated since convention. It throws the membership info off. It was asked which 2 had updated and Randy didn't know as he hadn't written it down.

 - *Hy Libby spoke about the Epic Ride. It's a fundraiser for phase 2(in ground burials) at the California Central Coast Veterans Cemetery. Phase 1 took 28 years and is only for cremated remains. It's a one month ride from early September through early October. Daily events on Facebook page. Ambassadors for the state and the chapter as we meet riders from across the country and hopefully pick up some donations. Lost a major donor. Trying to make up a 2M\$ shortfall. More information at EPICRIDE2017.ORG John Archuleta asked Hy to call him about possible donations. On July 9th will have a 2 hour stint on a radio show called "Vets Get It Done".
